

# GIVING GUIDE

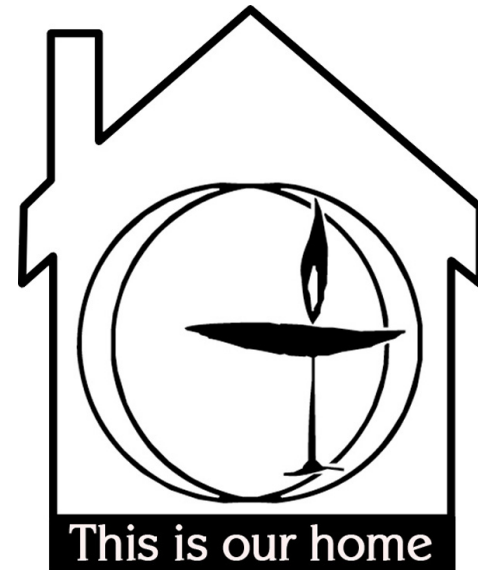
Following are four different levels of giving to consider:

**Level 1:** 2.5% of adjusted gross income-  
You believe that the Congregation and Unitarian Universalism are valuable forces for good and worthy of your support; however, the UUC is not necessarily more important to you than other commendable non-profit organizations.

**Level 2:** 4% of adjusted gross income-  
The Congregation and your Unitarian Universalist identity are important parts of your family's spiritual and social life. You understand that, as a small organization, the Congregation counts on your meaningful financial support for its survival and growth.

**Level 3:** 6% of adjusted gross income-  
The Congregation and your Unitarian Universalist identity are central to your family's spiritual and social life. You understand that full-time ministry will help the local UU community touch more lives more profoundly. You also realize that professional staff comes at a substantial cost.

**Level 4:** 10% of adjusted gross income-  
You are a "visionary" who believes that generous financial support of the Congregation is one way to put your spiritual principles into action.

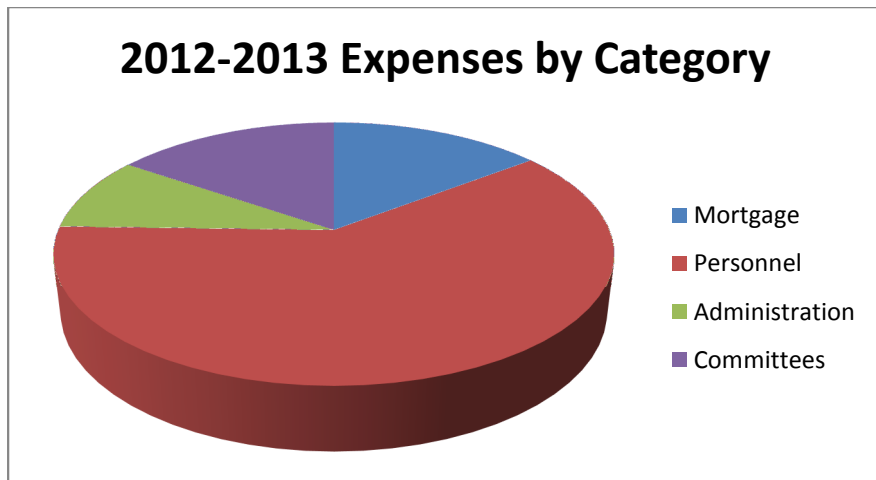
